



Mastering Follow-Up:

Please read and understand these items before submitting your master for replication.

Masters and Refs:

For most projects you will receive (1) PMCD (Pre-Mastered Compact Disc) and (1) Mastered Reference. The PMCD is your replication master and should be kept ABSOLUTELY PRISTINE! One fingerprint or spec of dust can render the master un-useable. We recommend that you DO NOT play this disc, only your Mastered Reference. When listening, you want to be sure the audio sounds exactly as you wish and that there are no dropouts or digital glitches. Also be sure to check the start ID of each track to be sure that no intros are clipped. Keep in mind that on tracks that have been "cross-faded" you may hear a bit of the audio from the previous track when you advance to the following track – this is related to the differing un-mute times on CD/DVD players and is un-avoidable. If the ID point is unacceptable – a change may resolve the issue – though certain players may clip the intro if the point is moved too close to the oncoming audio.

Your Mastered Reference will serve as both your master safety and your "running" master. This is an exact duplicate of your master and can be used to generate additional refs. This is the disc you'll want to throw in the car CD player on the way home to check out the day's work and enjoy!

CD Text:

Don't be alarmed when you put your CD into your computer at home and the track listing does not automatically show up as it does with your store bought discs, or gets mislabeled. While your CD could have CD Text encoded, software media players do not pull this information from the disc. Programs such as iTunes or Windows Media Player automatically matches the disc parameters with comparable information listed in online databases (such as Gracenote and AMG Lasso) that the software queries. Since we have just created a new CD you must submit your CD's information to these online databases to eliminate these issues for you and your fans. It is generally best to do this after you have received your replicated discs back from the manufacturer. For information on how to accomplish this please visit the links below.

Changes and Revisions:

While we strive to get everything correct the first time, occasionally revisions are needed. These may be as simple as adjustment of the levels of songs, track spacing changes or song re-sequencing or as complex as remixing entire songs, mastering the new versions and editing them back into the album sequence. SMM bills changes to a master at 1/2 your initial hourly rate + materials. For example – if you're hourly rate for mastering was \$300/hour and you needed 1 hour of changes, a new master and a new ref – the cost for the changes would be \$150 (time) + the cost of the master and the ref. This allows you to make needed changes without incurring an excess of additional costs while ensuring you restrict changes to those that make the album better, not just different. Please note that master files are held on our system (and are therefore accessible for changes) for a period of (10) business days after the original mastering session. If changes are needed – be sure to alert your engineer WITHIN (10) business days of your original mastering date so that a touch-up session can be scheduled without incurring additional reloading charges. The current rate for reloading is \$150 per disc, regardless of program length and includes re-loading and re-insertion of all PQ information.

Credits:
